DRAW AND DEADLINES:

The Draw will be held at the office of Kids Cancer Care Foundation of Alberta 5757 4 St SE, Calgary, AB. T2H 1K8.

The Final draw for 50% of total ticket sales will be held at 10:00am on June 1, 2026. Only tickets purchased before 9:00am on June 1, 2026 will be eligible for this draw.

Any winning ticket drawn will be returned to the draw to remain eligible for any subsequent draws.

Prize draws follow a strict set of procedures, with draw control oversight by Trellis Social Enterprise Inc. and under licensing approval by the licensing body, Alberta Gaming, Liquor and Cannabis (AGLC). Each prize draw will be conducted in accordance with the approved Raffle Terms and Conditions as put forth by AGLC. Draws are conducted using a Random Number Generator (RNG) system, certified, and approved by AGLC.

All the above-mentioned draws are open to any member of the public wishing to attend. Two lottery representatives or their designates will be present for all draws.

Only upon demonstrating extraordinary circumstances to Alberta Gaming, Liquor and Cannabis will the Licensee make a request for a draw date extension.

Files are continuously backed up by Trellis Social Enterprise Inc. In the unexpected event of a power failure, the draw will be postponed and take place immediately once power has been restored.

ELIGIBILITY:

Raffle guidelines prohibit the following people from purchasing tickets:

- a. Kids Cancer Care Foundation of Alberta Board members and members of their immediate family including spouse, parents, children or siblings which reside in the same household.
- b. Kids Cancer Care Foundation of Alberta salaried team.
- c. Employees of Trellis Social Enterprise Inc. and members of their immediate family including spouse, parents, children or siblings which reside in the same household.
- d. If a minor purchases a ticket, it will be deemed void, and the purchaser will be refunded.

PRIZE:

The Winner will be notified by telephone and/or email by lottery representatives; detailing what they have won and where they can claim their prize. Also, the name, city and winning ticket number will be published within 14 days on the Kids Cancer Care Foundation webpage.

Prizes must be accepted as awarded; there will be no cash substitutes unless otherwise stated.

Should the prizes not be claimed within three months of the draw date, a request will be made to Alberta Gaming, Liquor & Cannabis for a decision regarding the disbursement of the prize.
